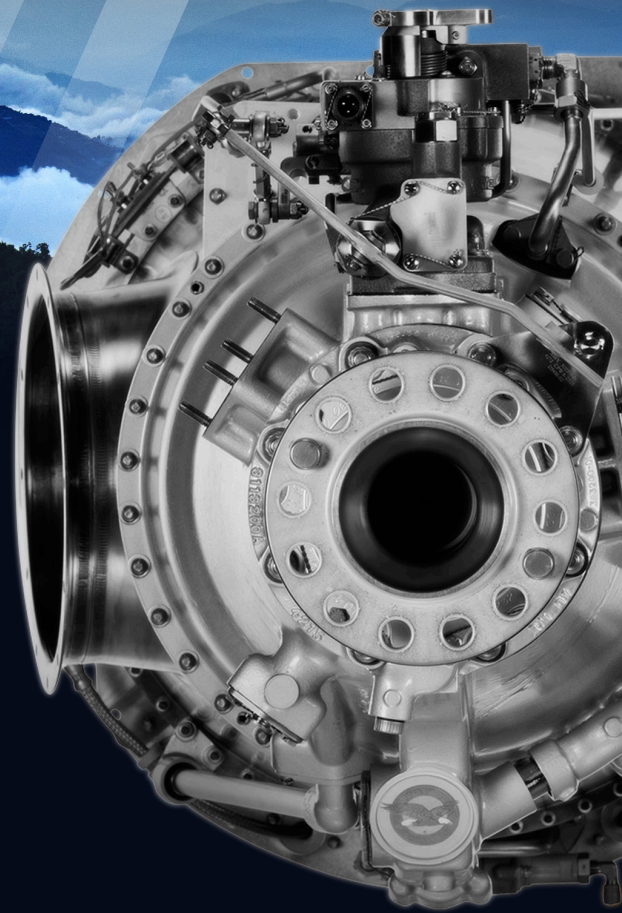

Pratt & Whitney Canada's Certified Pre-Owned (CPO) Engine program is about delivering greater value and peace of mind to PT6A-powered used-aircraft buyers and sellers. The program also supports aircraft dealers in differentiating their inventory – helping drive sales and reducing time on market.

How it works: PT6A engines that pass through a thorough certification inspection are eligible for a two-year/500-hour warranty (whichever comes first).

For buyers, it means you can have complete confidence in your used aircraft's powerplant – along with the peace of mind provided by genuine P&WC parts and maintenance. It also simplifies the buying process by combining a pre-buy inspection with an OEM-backed extended engine warranty.

For dealers, it means greater value for your used PT6A-powered aircraft, enabling you to sell your assets more quickly and enhance customer satisfaction.

The CPO Engine Program is another way we are delivering on our commitment to offering programs suited to every stage of the engine lifecycle, bringing greater value and more options to our customers.

WHICH ENGINES ARE ELIGIBLE?

The CPO Engine Program is offered for PT6A engines that:

- have been maintained at P&WC-owned or -designated facilities
- have only genuine P&WC parts
- pass an inspection conducted by P&WC

HOW ARE ENGINES CERTIFIED?

Used-aircraft dealers submit engines to have their eligibility certified by P&WC experts, including:

- review of maintenance records
- visual inspection
- power assurance run
- borescope inspection
- Oil Analysis Technology assessment

WHAT DOES THE WARRANTY COVER?

The warranty lasts for two years or 500 flight hours from the date of activation. It covers repair or replacement of any engine parts found to be defective, plus any engine damage caused by the defective part.
