## General Terms and Conditions of Purchase – Supplement 2 **Raytheon** Government Contract Provisions from the Department of Defense FAR Supplement (DFARS) TC-003 (03/09)

When the materials, products or services furnished are for use in connection with a U. S. Government Department of Defense Prime Contract or higher-tier subcontract, in addition to the General Provisions (TC-001) and the FAR provisions (TC-002), the following DFARS clauses and provisions (TC-003), shall apply, as required by the terms of the prime contract or by operation of law or regulation. However, the words "Government" and "Contracting Officer" do not change: (1) when a right, act, authorization or obligation can be granted or performed only by the Government or the prime contract gofficer or his or her duly authorized representative, and (2) when tille to property is to be transferred directly to the Government. "Subcontractor," however, shall mean "Seller's Subcontractor" under this Purchase Order. The listed DFARS clauses are incorporated herein as if set forth in full text unless made inapplicable by their corresponding notes, if any. If any of the following DFARS clauses do not apply to this Purchase Order, such clauses are considered to be self-deleting. The Seller, by signing its offer, hereby certifies compliance with the following clauses and is, therefore, eligible for award. With respect to any applicable DFARS clauses incorporated into this Purchase Order relating to rights in noncommercial technical data and noncommercial computer software and noncommercial computer software and/or noncommercial computer software documentation delivered under this Purchase Order to the extent necessary, and for such period as is required, for Buyer to complete its performance under the Buyer's U.S. Government programs.
