GENERAL TERMS AND CONDITIONS OF PURCHASE – Supplement 4 Government Contract Provisions from the Department of Energy Acquisition Regulation (DEAR) TC-DEAR (10/11)



- A. When the materials, products or services furnished are for use in connection with a U.S. Government, Department of Energy contract or higher-tier subcontract, in addition to the General Provisions (TC-001) and FAR provisions (TC-002), the following provisions shall apply, as required by the terms of the prime contract, higher-tier subcontract or by operation of law or regulation. The effective version of each DEAR provision shall be the same version as that which appears in Buyer's prime contract, or higher-tier subcontract under which this Order is a subcontract, in the event of a conflict between these DEAR provisions and the General Provisions (TC-001) or FAR provisions (TC-002), the DEAR provisions shall control.
- B. The following clauses set forth in the DEAR in effect as of the date of the prime contract are incorporated herein by reference. In all clauses listed herein, the terms "Government", Contracting Officer" and "contractor shall be revised to suitably identify the contracting parties under this Purchase Order and effect the proper intent of the provision except where further clarified or modified below . "Subcontractor", however, shall mean "Seller's Subcontractor" under this Purchase Order. The Seller, by signing its offer, hereby certifies compliance with the following clauses and is, therefore, eligible for award. With respect to the FAR and DEAR clauses incorporated into the Purchase Order relating to rights in noncommercial technical data, and noncommercial computer software and noncommercial computer software documentation, the Seller grants to Buyer the right to use, disclose, modify, combine, integrate or make derivative works of any noncommercial technical data, noncommercial computers software or noncommercial computer software documentation delivered under this Purchase Order to the extent necessary, and for such period as is required, for Buyer to complete its performance under the Buyer's U.S. Government programs.
