

The following updates reflect changes to various provisions and clauses of U.S. Government acquisition regulations, including the Federal Acquisition Regulations (FAR) and the Department of Defense FAR Supplement (DFARS). By this reference, said updates are incorporated in and made an integral part of the General Terms and Conditions (TC) documents identified below.

- A. Update to TC-001 (10/17), GENERAL TERMS AND CONDITIONS OF PURCHASE
 - 1. As a result of the DFARS Final Rule the following clause is ADDED to Paragraph 19(e)B as Subparagraph 25:
 - 25. **252.215-7010** "Requirements for Certified Cost or Pricing Data and Data Other Than Certified Cost or Pricing Data" (Applicable to Purchase Orders exceeding the simplified acquisition threshold defined in FAR part 2.)
 - 2. As a result of the FAR Interim Rule the following clause is ADDED to Paragraph 19(e)A as Subparagraph 31:
 - 31. **52.204–23** "Prohibition on Contracting for Hardware, Software, and Services Developed or Provided by Kaspersky Lab and Other Covered Entities"
 - 3. As a result of the DFARS Class Deviation 2018-O0020 the following clause is ADDED to Paragraph 19(e)B as Subparagraph 26:
 - 26. **252.239-7018** Supply Chain Risk (DEVIATION 2018-O0020) (Applicable to Purchase Orders involving the development or delivery of any information technology under DoD contracts awarded after September 18, 2018).
- **B.** Update to TC-002 (10/17), GENERAL TERMS AND CONDITIONS OF PURCHASE Supplement 1, Government Contract Provisions from the Federal Acquisition Regulation
 - 1. As a result of the FAR Interim Rule the following clause is ADDED to Section A as Subparagraph 44:
 - 44. **52.204–23** "Prohibition on Contracting for Hardware, Software, and Services Developed or Provided by Kaspersky Lab and Other Covered Entities"
 - 2. Class Deviation 2018-O0015 is added to Section K Subparagraph 3, 52.215-12 "Subcontractor Certified Cost or Pricing Data"
 - 3. Class Deviation 2018-O0015 is added to Section K Subparagraph 4, 52.215-13 "Subcontractor Certified Cost or Pricing Data Modifications"
- **C. Update to TC-003 (10/17),** GENERAL TERMS AND CONDITIONS OF PURCHASE Supplement 2, Government Contract Provisions from the Department of Defense FAR Supplement
 - 1. As a result of the DFARS Class Deviation 2018-O0020 the following clause is ADDED to Section A as Subparagraph 59:
 - 59. **252.239-7018** Supply Chain Risk (DEVIATION 2018-O0020) (Applicable to Purchase Orders involving the development or delivery of any information technology under DoD contracts awarded after September 18, 2018).



- D. Update to TC-004 (10/17), INTERNATIONAL GENERAL TERMS AND CONDITIONS OF PURCHASE
 - 1. As a result of the DFARS Final Rule the following clause is ADDED to Paragraph 19(e)B as Subparagraph 25:
 - 25. **252.215-7010** "Requirements for Certified Cost or Pricing Data and Data Other Than Certified Cost or Pricing Data" (Applicable to Purchase Orders exceeding the simplified acquisition threshold defined in FAR part 2.)
 - 2. As a result of the FAR Interim Rule the following clause is ADDED to Paragraph 19(e)A as Subparagraph 29:
 - 29. **52.204–23** "Prohibition on Contracting for Hardware, Software, and Services Developed or Provided by Kaspersky Lab and Other Covered Entities"
 - 3. As a result of the DFARS Class Deviation 2018-O0020 the following clause is ADDED to Paragraph 19(e)B as Subparagraph 26:
 - 26. **252.239-7018** Supply Chain Risk (DEVIATION 2018-O0020) (Applicable to Purchase Orders involving the development or delivery of any information technology under DoD contracts awarded after September 18, 2018).
- **E. Update to TC-004F (10/17),** INTERNATIONAL TERMS AND CONDITIONS OF PURCHASE Supplement 1 Government Contract Provisions from the Federal Acquisition Regulation
 - 1. As a result of the FAR Interim Rule the following clause is ADDED to Section A as Subparagraph 33:
 - 33. **52.204–23** "Prohibition on Contracting for Hardware, Software, and Services Developed or Provided by Kaspersky Lab and Other Covered Entities"
 - 2. Class Deviation 2018-O0015 is added to Section K Subparagraph 3, 52.215-12 "Subcontractor Certified Cost or Pricing Data"
 - 3. Class Deviation 2018-O0015 is added to Section K Subparagraph 4, 52.215-13 "Subcontractor Certified Cost or Pricing Data Modifications"
- F. Update to TC-004D (10/17), INTERNATIONAL GENERAL TERMS AND CONDITIONS OF PURCHASE Supplement 2 Government Contract Provisions from the Department of Defense FAR Supplement
 - 1. As a result of the DFARS Class Deviation 2018-O0020 the following clause is ADDED to Section A as Subparagraph 55:
 - 55. **252.239-7018** Supply Chain Risk (DEVIATION 2018-O0020) (Applicable to Purchase Orders involving the development or delivery of any information technology under DoD contracts awarded after September 18, 2018).
