



RTX Corporation and its subsidiaries and affiliates (collectively, "RTX") seek to take photographs, videos and/or audio recordings of you for use in internal and external communications.

**What personal information will be collected?**

RTX will collect your visual image (photograph), video, and/or audio recording. RTX will also collect your contact information to manage this consent and follow-up with you, if needed. Contact information may include your name, email address, home address, telephone number, and other contact method. Depending on the nature of the photo shoot or recording, RTX may also seek information about your role and/or ask to interview you.

**For what purposes will the personal information be used?**

The personal information will be used for both internal and external communications. Internal communications include messages targeted at RTX employees, such as articles on RTX's internal website and internal email messages. External communications include messages targeted at investors, media, prospective employees and the general public in material posted on our external website, our annual report, social channels and other company materials.

**With whom will the personal information be shared?**

The personal information will be shared with members of the Communications department within RTX. It will also be shared with certain service providers, such as consultants that assist with the production of our company materials, outsourced IT support and storage, and the company that provides the tool for storage of company photos and recordings. RTX will only share the information with service providers for the purposes outlined above and where the service providers are contractually prohibited from using the photos and recordings except when it is necessary to perform services on our behalf or to comply with legal requirements. Because RTX is a global company, the personal information may be transferred to other countries (including ones deemed not to have adequate privacy laws by the EU), but RTX will do so consistent with applicable law, its Binding Corporate Rules, and, if to a service provider, subject to appropriate contract terms.

It is unlikely but possible that we may also need to share the personal information with third parties, such as service providers, government agencies, or other companies to:

- Comply with legal obligations, including but not limited to complying with regulatory obligations, responding to a court proceeding or a legitimate legal request from law enforcement authorities or other government regulators;
- Investigate suspected or actual illegal activity;
- Prevent physical harm or financial loss; and
- Support the sale or transfer of all or a portion of our business or assets (including through bankruptcy).

As the photographs and recordings are being collected for the purpose of internal and external communications materials, the images and recordings may be shared with RTX employees and publicly. If you would like to limit usage, you can do so in the box below or at any time later by contacting [privacy.compliance@rtx.com](mailto:privacy.compliance@rtx.com), but RTX will only be able to limit future usage.

**Where and how long will the personal information be stored?**

The personal information will be stored on RTX's networks and systems, in cloud services procured by RTX, in a software tool specifically designed to manage this type of information and used for communications materials. The personal information will be stored for as long as required for the original purpose for which it was collected, unless otherwise required by law. If you would like RTX to purge your personal information, please email [privacy.compliance@rtx.com](mailto:privacy.compliance@rtx.com) to make a request, but note that we may be unable to delete certain materials, such as annual reports or publicly released marketing materials, which we may be required to retain by law or may no longer control.

If requested, RTX will make a reasonable effort to discontinue electronic use of my personal information, but RTX is not able to purge copies no longer in its possession.
